SUMMARY OF PUBLIC SAFETY COMMITTEE RECOMMENDATION

The Public Safety Committee met on February 26 to review both the Executive's recommended FY19-24 CIP, and the Executive's Supplemental Appropriation and CIP Amendment for the Public Safety Communications Center (PSCC). The Committee voted on both measures to recommend approval (3-0) as submitted by the Executive. Council approved the PSCC supplemental appropriation and CIP amendment on March 6.

OVERVIEW

The FY19-24 Capital Improvements Program (CIP) for MCPD has three projects at a cost of \$33.5 million over the next six years. This is an increase of almost \$24 million from the approved FY17-22 CIP of \$9.7 million. The most significant changes are the addition of the new Public Safety and Communications Center (PSSC) project for \$8 million and the new 6th District Police Station for \$25 million. The recommended CIP also has ongoing costs associated with the Public Safety Training Academy (PSTA) Academic Building Complex. The following table illustrates the FY19-24 CIP projects and spending:

This new project provides for the renovation and purchase of the Public Safety Communications Center (PSSC). Currently, the Emergency Communications Center, which handles 911 and non-emergency public safety calls, is located in leased space in the Gaithersburg area. The \$8 million, which is programmed in FY19, will be used to purchase the building. A portion of the purchase cost may be funded through ALARF. Purchase of the building is expected to result in approximately \$1.2 million savings in annual rental costs.

The Committee also reviewed an amendment to the FY17-22 CIP and a supplemental appropriation to the County Government's FY18 Capital Budget for the Montgomery County Police Department (MCPD) in the amount of \$3,009,000 to pay improvements to the heating, ventilation, and air conditioning (HVAC) systems and other building systems to create a backup system to support the County's 911 service. The source of the funds is G.O. Bonds. The Council introduced the resolution on January30, held a public hearing on February 13, and approved the supplemental appropriation on March 6. This project was first introduced in the CIP in FY01-06 CIP. At that time, design was programmed to begin in FY06. The project was delayed the following CIP cycle, and continued to get delayed. Finally, in FY13, the project was indefinitely deferred due to fiscal constraints.

It has been placed back in the recommended FY19-24 CIP, and provides for the planning, design, and construction of a new 28,294 square foot 6D police station, and a new 59,526 square foot parking garage to serve Gaithersburg and Montgomery Village. The building will be in a

new development located on Watkins Mill Road between I-270 and MD-355. The building is to consist of two floors, and provide parking for the public and staff. Surface parking will be available and will provide 37 parking spaces in non-secured area. A parking garage that will accommodate 160 cars will be constructed inside a secured area. The parking garage will also house a large evidence room, a vehicle service bay, and bicycle and motorcycle storage. This project is scheduled to start construction in the fall of 2022 and finish in winter of 2024.

For FY11-16, the County Executive is recommending funding of \$21,667,000. Design is complete, although the project is currently on hold due to a delay in the construction of the Watkins Mill Road Extension.

The current facilities are in leased space and do not have several features that are necessary for a police station, such as reinforced interview rooms and a dedicated sally port.

This project had originally been introduced in the FY99 for the purposes of renovating the existing PSTA, which had not been substantively changed since it was built in 1973. The project was pending close out since FY11 due to the new Smart Growth Initiative, which relocated the PSTA to Snouffer School Road. The old site was to be sold and be used for housing development.

The project has been added back to the CIP this year for demolition purposes. Demolition has been completed and permits are pending close-out this spring. Final costs have not yet been reconciled. When they are, the Executive will share them with the Council. The Executive indicates there is an active solicitation for the purchase of the site.

Status Update on 2D Police Station

The use and occupancy for the 2D police station was issued in January, and a ribbon cutting took place on January 22. The Station opened on February 15. The Police have seven days from February 15 to completely vacate the old 2D District Station.

Project Description

This project provides for planning, design and construction of a new 28,294 gross square feet 6th District Police Station and a new parking garage of 59,526 gross square feet in two levels to serve Gaithersburg/Montgomery Village and vicinity. The Station

44 (3) will be in a new development located on extended Watkins Mill Road between I-270 and MD-355. The prototype district station is a facility consisting of two floors and parking for the public and staff. The first floor houses the public access area, operations, patrol and support functions, and includes a small prisoner holding area. The second floor houses investigative units, staff support, and administration. Besides a surface parking lot that will provide 37 parking spaces in the non-secured area, a parking garage to accommodate 160 cars will be constructed inside the secured area. This parking garage will house a large evidence room, a vehicle service bay, and bicycle and motorcycle storage. The district station is a 24-hour per day, seven-day per week operation and provides support for beat teams. It is the command center for any satellite facilities within the police district. The district station will accommodate up to 161 department staff and volunteers. It has been sized to meet the needs projected in the Police Chief's Staffing Plan. A public meeting room will be available to facilitate outreach with the community.

Location

Watkins Mill Road between I-270 and MD-355.

Estimated Schedule

This project is scheduled to start construction in Fall 2022 and finish in Winter 2024.

Cost Change

The cost of construction and equipment was added in the FY19-24 full CIP.

Project Justification

The current facility is in rented space and lacks several features of a modern police station, including reinforced interview rooms and a dedicated sally port.

Fiscal Note

FY17 transfer of \$50,000 in G.O. Bonds to 3rd District Police Station (#047302).

 - a. How many parking spaces are available for police parking? 75 secured spaces.
 - b. What is the status of the old 2D police station? Has title been transferred to the developer yet?

 Transactions will also occur on the 15th at which time the County will receive the new station and the developer will take possession of the former station site. Police have 7 days from February 15th to completely vacate the old 2nd District Station.

Background

- 1. Section 307 of the Montgomery County Charter provides that any supplemental appropriation shall be recommended by the County Executive who shall specify the source of funds to finance it. The Council shall hold a public hearing on each proposed supplemental appropriation after at least one week's notice. A supplemental appropriation that would comply with, avail the County of, or put into effect a grant or a Federal, State or County law or regulation, or one that is approved after January 1 of any fiscal year, requires an affirmative vote of five Councilmembers. A supplemental appropriation for any other purpose that is approved before January 1 of any fiscal year requires an affirmative vote of six Councilmembers. The Council may, in a single action, approve more than one supplemental appropriation. The Executive may disapprove or reduce a supplemental appropriation, and the Council may reapprove the appropriation, as if it were an item in the annual budget.
- 2. Section 302 of the Montgomery County Charter provides that the Council may amend an approved capital improvements program at any time by an affirmative vote of no fewer than six members of the Council.
- 3. The County Executive recommends the following capital project appropriation increases:

4. This increase is needed because the building support systems are in need of improvement, particularly the heating, ventilation, and air conditioning and electrical systems. The recommended amendment is consistent with the criteria for amending the CIP because the project addresses a safety concern and offers an opportunity to achieve significant future savings.

- 5. The County Executive recommends an amendment to the FY17-22 Capital Improvements Program and a supplemental appropriation in the amount of \$3,009,000 for the Public Safety Communications Center (No. 471802) and specifies that the source of funds will be G.O. Bonds.
- 6. Notice of public hearing was given and a public hearing was held.
