VICTOR BEECHER

Director of Programs & Events, Northwestern University Center for Public Safety

A 26-year veteran of the Milwaukee Police
Department, Victor Beecher rose through patrol
and investigative ranks and retired in 2016 at the
rank of Captain, last serving as the commanding
officer of Milwaukee's District Four. Leading over
130 officers in a 28 square-mile District area
and over 70,000 residents, he was responsible
for all police operations and implemented datadriven, community-engaged, proactive strategies
in order to reduce crime, fear, and disorder.
Previous assignments included Police Academy
Director. Beecher is a graduate of the University of
Wisconsin-Milwaukee as well as a graduate of the
Center for Public Safety's School of Police Staff and
Command.

JOHN FURCON

Director of Research & Consulting, Northwestern University Center for Public Safety

John Furcon led numerous consulting and research projects to improve the capability and performance of municipal, county, and statewide police agencies throughout the U.S. Examples include strategy and talent management work with the Illinois State Police, introducing Respect Based Leadership in the Los Angeles County Sheriff's Department, and work with community leaders in improving police-community relations in Detroit. He holds graduate degrees in management, organizational behavior, and psychology from the University of Chicago and DePaul University.

Mark Iris supervises research on police operations using databases provided by major city departments including New York, Los Angeles, Houston and Philadelphia. For 21 years, he served as Executive Director of the City of Chicago Police Board, which is responsible for conducting hearings on police misconduct complaints as well as vetting candidates for the position of Police Superintendent. Iris teaches undergraduate, graduate, and law school classes in law and politics. He earned his PhD at Northwestern University and has written articles on policing issues for *The Police Chief*, *Police Quarterly*, and other journals.
