While not ignoring offender-based strategies, CPOP focuses more broadly on reducing opportunities for crimes to occur in specific situations to prevent individuals from becoming victims. Becky has a bachelor's degree in Urban Studies (with a specialty in psychology) from Wright State University and a Master's Degree in Public Administration. She is acting President of Ohio Crime Prevention Association as well as Secretary for the Miami Valley Crime Prevention Association.

As a graduate of Ohio Peace Officer's Training Academy he has been a certified police officer with the city of Dayton since 2007.
