I was desperate and then saw Dr Peter Lewis, who also agreed that I had an auto immune response to the vaccine and possibly had auto immune disease thereafter. We did a series of blood tests looking at my vitamin and mineral blood count, finding I was also low in vitamin D: I was prescribed 10,000 iu of vitamin D a day, alongside zinc, coenzymes, and had a B 12 injection and most importantly, also went on a series of eight days with ivermectin. Monday 4th October: I attended the pharmacy with a weight on my chest knowing I did not want this vaccination, I was put into a room by the pharmacist with a kidney dish and a syringe, there was no accompanying vial, no sticker, no sort of identification or paperwork, I questioned what I was receiving and I should have requested to see the vial, she went to say that AZ was white and Moderna was milky white, I do not know the dose I received. After receiving the ModVax, I felt a thermal cold burning sensation at the injection site and into my left arm around the site, this remained for a few hours. Monday evening at 2200hrs I felt across my chest a severely profound thermal cold burning feeling which was also filled with an adrenaline and nervous/anxious feeling, I had not been anxious prior to this and I believe it was my body causing these feelings, not my head. This was a all consuming feeling and I tried many distractions and activities to calm my mind and stop the feelings because at the time I hadn't realized it was the beginning of my reaction. I did not sleep Monday night. Tuesday 5th October: I went up to work for FMG for the day and will fly home Wednesday AM. I have been having the same chest feeling but not to such a severe degree. At 0130 I finally managed to get 4-5 hours sleep at this point I had been awake for 40 hours straight without sleep. Wednesday 6th October: after watching a movie with my children, I put
