BCSD Reimagined:

Shaping Our Schools For The Future

Dear Batavia Families and Community,

On behalf of our Board of Education, I am both pleased and proud to present to you our 2023 Capital Project: "BCSD Reimagined: Shaping Our Schools For The Future."

This project represents several years of careful planning between the district and our professional partners (our architects and construction management team), and is designed to provide significant capital improvements without expanding the footprint of our district—or in other words, no new additions to our current schools and facilities.

As a district, we have an obligation to maintain and improve our facilities, and as such, this project contains important items such as roof replacements, foundation repairs, parking lot improvements, safety enhancements, and improvements to our athletics and music facilities. We are also providing support to our friends at the Richmond Memorial Library, as the district also owns our historic library.

A hallmark of this plan, however, is returning fifth grade to an elementary school setting—John Kennedy Intermediate School. Grades will then shift accordingly (please be sure to review the plan included in the pages that follow). A second hallmark of the plan is to have Robert Morris become an early childhood center, housing Universal Pre-Kindergarten, Pre-School, and Kindergarten. Over the past several years, New York State has provided significant support to districts such as ours to provide a laser-sharp and intense focus on early childhood education.

We are pleased to inform you that there will be NO ADDITIONAL TAX INCREASE as a result of this project.

Through careful financial planning, the district will be capitalizing on State Building Aid, with the balance of the project supported through capital reserves. Preventive maintenance and regular upkeep of our facilities—while serving our community as financial stewards—is a critical part of my role and our Board of Education.

There are two information sessions scheduled where the project will be reviewed in detail, with time for questions. Dates, times, and locations for these meetings, and more details about the project, are provided in this newsletter.

BCSD Reimagined: Shaping Our Schools For The Future

On Thursday, December 14, 2023, Batavia City School District residents will have an opportunity to vote on a proposed capital improvement project that is designed to modernize our instructional spaces, optimize our building grade-level configuration, and address high-priority facilities needs throughout our District. The BCSD Reimagined project will also prepare our school buildings for planned grade-level reconfigurations to maximize equity, opportunity, and educational outcomes for our entire student population.

It was a priority of the Board and our leadership team that this capital improvement project comes at no additional cost to our Batavia community. Through diligent analysis of our student enrollment projections, academic enrichment opportunities, and asset preservation needs, along with dutiful financial planning and optimization of State Building Aid, we are able to propose the BCSD Reimagined project with no annual increase to taxpayers.




A Closer Look:

Grade-Level Reconfiguration Plan

Several studies bring to life the positive impact of bringing students of all demographics together within a school system. This model is known as the Princeton system. The main advantage of combining students in the same grade levels and educating them together in the same school, rather than geographically dividing grade levels across neighborhood schools, is to promote equity, diversity, and parity in the academic resources and enrichment programs that are available to all students, regardless of demographics such as race, economic status, and neighborhood location.

By reconfiguring our grade levels in this manner, we are positioning our 2,200 Batavia City School District students for equitable educational opportunities, successful learning pathways, and positive outcomes. Empirical evidence shows that combined, heterogeneous classroom environments can dramatically improve achievement and decrease inequalities in education.

With the evidence produced by these studies in mind, the BCSD Reimagined project provides the perfect opportunity to bring our students together with everyone in their grade level, creating an environment that will make the advantages of equality a reality for all students throughout our district. The chart below illustrates the new district-wide grade-level configuration plan for Batavia City School District.

Synthetic Turf Fields for JV Baseball & Varsity Softball

Upgrading our JV Baseball and Varsity Softball fields at the High School will extend playability by improving field drainage and reducing maintenance costs over time. The wet spring and fall weather in our region frequently causes our current grass fields to become muddy, slippery, and unsafe for play. Modern synthetic field systems are a safe and cost-effective solution to these issues, allowing our student athletes and physical education programs to play ball in competition and in class. The field systems will also be made "light-ready" for potential future field lighting.





Project Financing Plan


Project Budget

BCSD Reimagined: Frequently Asked Questions

Why is the District proposing a capital project vote now?

Batavia City School District is committed to exercising care and good judgment in managing the community resources with which we are entrusted. We need to continue to take care of our schools, an important asset the community owns. Just as one's home ages and needs renovations and upkeep to keep it in good shape, so do our schools. The District is addressing its highest-priority facilities issues now, rather than delaying and facing future higher costs and further deterioration. Sizable renovations like those included in this project would have a major impact on the tax rate if included in the annual District budget. A capital project is a fiscally responsible approach because the State reimburses a vast majority of the construction costs that would otherwise be funded by the local taxpayers.

How were the project's components chosen?

Over the past several years, the District administration and Board of Education have been working with consultants to assess current and future capital improvement needs and the means to responsibly achieve them. During this process, critical safety upgrades and building preservation needs were identified and prioritized, as were opportunities to enrich our students through grade-level reconfiguration and educational program enhancements. To evaluate conditions at all facilities, the District utilized its Building Condition Survey (BCS), which is mandated by the State to be conducted every five years, and considered work completed in previous projects. Safety concerns, BCS items, and academic program enhancements received top priority, as did code compliance, mechanical systems, and building envelope (roofs and exterior wall systems) items.

What is the total cost of this proposed project, and how can it have NO ADDITIONAL TAX IMPACT?

The total cost of the project is \$45,060,486. The project will be paid for using a combination of available State Building Aid and funds from the District's Capital Reserve, which is designated to be used specifically for capital improvements. Since the Capital Reserve will cover the local share that is not eligible for State Building Aid reimbursement, there is no resulting additional tax increase for district residents and businesses.

Isn't State Aid just my tax dollars too?

Yes, it is. The New York State Legislature has given all Districts in the state an opportunity to use tax dollars to enhance their facilities through capital improvements and renovations. This is an opportunity to invest those tax dollars in our own

community, working to improve the educational setting for our children, families, district staff, and the public community long into the future.



How will the synthetic turf baseball and softball fields benefit our educational and community-based programs?

The benefits of synthetic turf fields are numerous and relevant to our physical education and athletic programs, youth group sports programs and use by our community. The following key benefits were identified during discussions with the directors and staff involved in these programs:

- Permanent markings and lines, making them ready for play without preparational adjustment.
- Less dependence on weather patterns, allowing for an extended duration of seasonal use. More games and practices can be held on a synthetic turf field in a given season, and it can be used extensively without the concern of muddying from inclement weather or overuse.
- Safe for players because the surface is consistent and not subject to uneven wear, grass length, and weed infestation.
- Available to be used for increased off-season usage by our students and available to be used by community organizations and individuals.
- Better preparation for our students to compete throughout the season, with a playing surface that is on par with other teams in our division.
- When comparing grass fields to synthetic fields, the costs to install and maintain them are approximately the same over a synthetic turf field's lifespan.

Are synthetic turf field materials considered safe?

The safety and well-being of our students are at the forefront of everything we do as a school district. Extensive research has been conducted for decades on the safety of synthetic turf materials by federal and state governments, universities, independent laboratories, and environmental organizations. The science concludes that the use of artificial turf poses no known health risk to children or adults.

When will the work take place?

After design submission, the State Education Department's approval for the first phase of work is expected in late 2024, with construction starting in summer 2025. The project is expected to reach final completion by the end of 2027.

- · A citizen of the United States
- 18 years of age
- A resident within the School District for a period of 30 days proceeding December 14, 2023

*No person shall have the right to register for or vote who would not be qualified to register for or vote in an election in accordance with provisions of Section 5-106 of the Election Law.

Absentee Ballot Information:

Qualified voters of the District may contact the district clerk at $585-343-2480 \times 1002$ to obtain an application for an absentee ballot. The application must be received by the district clerk at least 7 days before the vote if the ballot is to be mailed to the voter, or the day before the vote, if the ballot is to be delivered personally to the voter.
