Subject: Outdoor Cafes 2021 – during Covid19

Purpose

Obtain permission to allow an outdoor café for Mr. Mike's including an accessible stall.

Summary

- Mr. Mike's Steakhouse has requested the ability to construct an outdoor café in public space to allow for outdoor seating during the Covid19 restrictions.
- It was determined through a review of the site that the best location for this café is to utilize the
 accessible space including the sidewalk letdown and one additional parking stall fronting this
 business.
- Staff continue to work with the business to ensure the design and character of the proposed temporary outdoor patio is appropriate for Reid Street and the surrounding business community.
- In keeping with the commitment to expedite outdoor café permits for restaurants an electronic vote was requested on Friday April 16th. Results of that vote are attached.

Recommendation

THAT Council in recognition of the impacts of Covid19 restrictions to business authorize Staff to work with Mr. Mikes to permit an outdoor café utilizing one of the mid-block accessible stalls, the sidewalk to allow access to the letdown for accessible access to this outdoor café space and an additional abutting parking stall in front of their business on Reid Street;

AND THAT Council exempts strict compliance with all requirements of Outdoor Café Bylaw No. 1866, 2019, subject to city staff approval of the design and safety parameters proposed for outdoor spaces, during the 2021 outdoor café season.


It should be noted that the original Reid Street plan did not include two accessible stalls in this location and prior to adding the plan was already seen as being above many communities standards for provision of stalls.
