<u>Created</u> -- Maryland Code, Housing & Community Development Article, Sections 16-

105 -107.

Purpose -- The Housing Opportunities Commission is a public corporation chartered

under Maryland law. HOC builds, owns, manages and finances housing for people of eligible income. The Commission can issue tax exempt bonds to

finance multi-family rental housing and single family mortgages.

Membership -- Seven members. (A Federal law requires that at least one member of this

Commission be a person "who is directly assisted by the public housing agency."). *Members are required to be sworn in by the Clerk of the Circuit*

Court before their first meeting.

Financial Disclosure -- Public disclosure required.

<u>Terms</u> -- Five-year terms - no compensation.

<u>Meetings</u> -- First Wednesday evening of each month.

Elrich Seeks Applicants for Housing Opportunities Commission

County Executive Marc Elrich is seeking applicants to fill three vacancies on the Housing Opportunities Commission for two public members and one member who is directly assisted by the Housing Opportunities Commission either as a public housing resident or a recipient of housing assistance under the Housing Choice Voucher program. The incumbents are eligible to apply for reappointment.

The seven-member commission is responsible for building, managing and financing housing for low and moderate income people. Members serve five-year terms without compensation, but are eligible for reimbursement for travel and dependent care for meetings attended.

The Commission meets the first Wednesday of each month at 4:00 PM in Kensington. In addition, members are expected to attend regular committee meetings and property boards of directors to which they are assigned. Additional meetings are scheduled as needed. Members are required to attend at least 75 percent of the scheduled meetings.

Commissioners are required to file a public financial disclosure statement before County Executive appointment and annually thereafter, and are required to be sworn in by the Clerk of the Circuit Court before their first meeting.

Applicants of diverse, backgrounds, professions, genders, geography, abilities, ethnicities, and ages are encouraged to apply. Members of County boards, committees and commissions may not serve on more than one such group at a time. Members must complete training on the Maryland Open Meetings Act, Montgomery County Ethics Law, and basic parliamentary procedure. The County Executive's appointments are subject to confirmation by the County Council. Applications will be forwarded to the Council for confirmation.
