At U.S.VETS — Phoenix, we've been caring for our community's homeless and at-risk veterans for 19 years, serving more than 1,100 veterans annually. As the largest and only nonprofit specializing in veteran services in Maricopa County, we won't rest until every veteran has a place to call home.

There are men and women who have served our country bravely, but find themselves sleeping on the streets; a great national tragedy. As a nonprofit serving low-income individuals, U.S.VETS — Phoenix qualifies for the Arizona Charitable Tax Credit. This means you can donate up to \$800 for a joint return and up to \$400 for an individual return and may be able to deduct those amounts from your Arizona State Tax bill. U.S.VETS' programs are specifically designed to help our nation's veterans overcome life on the streets and move into stability, independence, and self-sufficiency. Your donation can mean the difference between a veteran living on the street or having a safe place to sleep.

## DONATE TODAY! HELP ENSURE CARE FOR A VETERAN.



\$800 can provide six days of shelter, meals and comprehensive services for a veteran



\$100 can provide one mental health assessment for a veteran



\$400 can provide 26 warm and nutritious meals to veterans



\$50 can provide one set of fresh clothing, toiletries and bedding to two veterans in transition from homelessness to housing

## You can receive a dollar-for-dollar credit on your Arizona state taxes by making a donation to U.S.VETS — Phoenix.

We know that tax credits are confusing so here are some important details:

Question: I donate to my child's school. Can I also donate to U.S.VETS — Phoenix?

Answer: YES! You can give to multiple causes depending on how much you owe the state. For example: You file your taxes jointly and would owe the state \$1,200, but you want to control how those dollars are used. You can donate \$400 (the max allowed) to your local public school AND \$800 (the max allowed) to U.S.VETS — Phoenix. Reducing the amount, you would pay the state to \$0.

Question: This sounds too good to be true. Is it?

Answer: It's not too good to be true. Tax credits have been around for years and in 2016, thanks to Governor Doug Ducey, the amount you can donate increased. Those filing Arizona taxes individually can donate up to \$400 and those filing jointly can donate up to \$800 to a qualified charitable organization, like U.S.VETS — Phoenix. This is on top of the public/charter school tax credit, private school tax credit and qualified foster care organization tax credit. You don't have to pick just one. Your credit can really add up.

Question: I cannot make a donation in one lump sum. Can I pay overtime?

**Answer: YES!** You can set up monthly payments with U.S.VETS — Phoenix. At the end of the year a donation summary letter will be sent to you to use when filing your taxes.
