Welcome adventure at Kah-Nee-Ta

The tribes are taking a step toward a new beginning at Kah-Nee-Ta. Along the way the resort will receive attention that is overdue.

A major investment in Kah-Nee-Ta requires a partner. Tribal Council and the resort board met last week with Tom Hansen and Michael Gaskin, senior partners with AV Northwest.

Over the past several weeks the parties have worked on an agreement that will lead to a long-term lease of Kah-Nee-Ta to AV Northwest. For its part the company will invest about \$17 million in the resort.

"We see Kah-Nee-Ta regaining its premier status as a family destination resort," Mr. Hansen said.

Central Oregon is one of the three top visitor areas in the U.S., he said. There are eight resorts in the region with only Kah-Nee-Ta not

doing well financially. Major improvements at the resort, and a new marketing strategy will correct the situation, Mr. Hansen said.

Kah-Nee-Ta has stayed open over the past few years through tribal loans, not a viable approach. Tribal Council and the board have known that 2017 would be a turn-

ing point for the resort.

They agreed early in the year that closure of Kah-Nee-Ta at the end of this season would be necessary if they could find no alternative. The resort employs many tribal members, and closure would be another fairly devastating blow to the reservation economy.

Some months ago the Kah-Nee-Ta Board of Directors reached out to AV Northwest, and the parties began researching and negotiating a possible agreement.

They have now reached terms calling for a lease of 25 years, during which time the management of the resort would be un-

der AV Northwest.

The hope is to have the lease finalized by the end of this year. With the lease in place, AV Northwest will make substantial infrastructure and other improvements at the resort, including at the Village.

The list of projects is extensive—a new heating and cooling system, new paint, improvements to the rooms, pools, restaurant and café, to name just a few. An interesting part of the plan is a new hydro- and physical therapy center at the Village. The hot springs would be put to use in the treatment of young people who are recovering from muscular and other conditions.

Marketing and customer relations are areas of expertise for Mr. Hansen.

Harrowing account of Las Vegas tragedy

Felicia Lopez drove down to Warm Springs from Spokane, where she lives with her family. As a graduation gift she was going to the Route 91 Harvest Festival, the big three-day Country music show in Las Vegas.

She stopped in Warm Springs to meet up with her sister Alexis Salazar, friend Reina Estimo and Alfred Estimo. Then the four of them drove down together to Las Vegas.

They stayed at the Hooters Casino Hotel, a couple of blocks from the concert venue. During the concerts, Reina, Alexis and Felicia liked to get close to stage, maybe just ten people back from the front. Rather than deal with the crowd Alfred would stay more

toward the back. Of course everyone had cell phones, so they always knew where each other were.

The show on Sunday evening was the main attraction, starring the headliner Jason Aldean. It was

a little after 10 p.m., and Aldean was just going into his fourth song. "I heard a popping noise," Alexis says.

As they were close to the stage, they saw smoke from one of the

speakers. Maybe it was a smoke bomb, "Then we heard the screams," she says.

The woman standing directly behind Reina was shot in the chest. She was wearing a white shirt, now red with blood.

In the panic of the crowd they got on the ground. Reina and Alexis lay on top of Felicia. "You could feel the bullets all around," Alexis says.

Reina braced herself on the ground. She didn't think about dying, "but I thought I was going to get shot. I was bracing myself to get shot."

The firing stopped for a moment and Felicia got up and jumped a fence.

Housing contends with unit meth contamination

More housing on the reservation has been a long-time need of the Confederated Tribes. In addressing the need the Housing Authority contends with various challenges, including one that is particularly costly, as well as in the end avoidable.

Many Housing Authority units have been contaminated by methamphetamine. The presence of meth residue in a residence is a serious health hazard, especially to children.

Very young children are at high risk because they spend more of their time indoors. Infants and young

children have greater exposure because they are rapidly growing, and have a higher rate of oxygen consumption.

There are currently 30 Warm Springs Housing units that are contaminated with methamphetamine. These are 30 units that are off-line during a time when tribal housing is in short supply.

The cost of cleaning a contaminated unit depends on the extent of contamination. But the cost can be in the tens of thousands of dollars per clean-up. The test itself is hundreds of dollars.

Contaminated items removed from a unit—carpet

and upholstery, for instance—have to be safely disposed of, either at Prineville, or in more serious cases at Arlington.

Housing relies on limited resources. HUD funding is the main source, with Housing using no tribal money.

The expense to decontaminate a Housing unit is unfair to the overall membership: One person can contaminate a unit, creating a large clean-up cost to Housing and the overall constituency.

Through HUD, Warm Springs Housing has cleaned several units, making them habitable again. Some of the staff at Hous-

ing are certified decontamination specialists.

Housing staff test units as they become vacant. A sample is taken from each room, and sent to a laboratory for analysis. A positive results requires closure of the unit until it is cleaned.

Meanwhile, Housing has been switching units from carpeting to nonporous tile, which can be easier to decontaminate.

Housing is also looking at holding the responsible person accountable. A possibility is making a person who has contaminated a unit disqualified for future use of a Housing unit.

Long-standing matter of jail condition

A new Warm Springs Jail and police-dispatch building is a priority project for the tribes, law enforcement, and for the BIA.

This project has, in fact, been a long-standing priority. For some time now Tribal Councilman Raymond Tsumpti has voiced concern about the condition of the jail, advocating for action on the project.

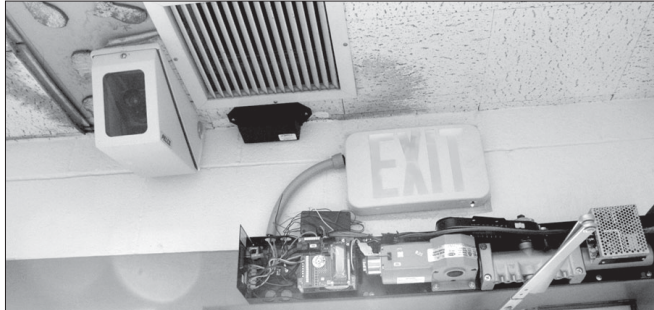
The jail is several years past its projected life expectancy, Councilman Tsumpti says. The facility was built in 1985 with a projected useful life of 25 years, or until 2010.

The jail and police-dispatch building is BIA-owned, operated by the tribes through the Public Safety Branch. Warm Springs BIA Agency Superintendent Lori Anderson is working on how to fund an updated tribal jail and police-dispatch.

The BIA itself is facing a possible 12-percent budget reduction in the coming year. But a possible funding source is the U.S. Department of Justice, through the

BIA Office of Justice Services, Ms. Anderson said.

Even in a best case scenario, though, the process could take two or more years, starting with a feasibility study, funding process, planning, and so forth.

Meanwhile, the situation in the jail at times becomes unacceptable. An example: Last winter the back-up generator went out leaving no power during an outage. There were no lights and no heat. The inmates had to

move for temporary incarceration at the Jefferson County Jail.

The county sheriff's office was very cooperative, but this and similar issues with the jail can be costly to Public Safety and the tribes.

Another example: There is no tribal juvenile detention facility. Instead, tribal police transport juveniles to Norcor at The Dalles. Driving back and forth from The Dalles takes away from the officers' time on the reservation, and leads to unavoidable overtime costs.

In the end the safety and well-being of the corrections officers and the inmates will require some action. "What we really need is a new building," said Public Safety General Manager Stan Suenaga.

The existing facility, he said, "absolutely needs work. The infrastructure in the building is wearing out."

Up until now and for the time being, though, the BIA budget has allowed only for reactive, "band-aid" fixes to the problems.

Land buy-back program gearing up

A large part of the Cobell lawsuit settlement went to a tribal land consolidation, or land buy-back program. On the Warm Springs Reservation this effort will be coordinated by Randy Scott.

Mr. Scott has been the tribal land services administrator in the planning department, but is in the process of transferring to program coordinator of the Warm Springs land buy back program. His office will be at the Media Center.

The Cobell settlement was for \$3.7 billion, divided among tribes across the country. Of that total, close to \$2 billion went to the land buy-back program, which each tribe administers for its own reservation.

The purpose of the buy-back program is to reduce fractionated interests. On the Warm Springs Reservation, this would apply to fractionated interests in allotments. As Mr. Scott explains:

The allottee process began 50 or 60 years ago. Originally, an allotment would likely be given to a single individual. Over the succeeding generations, though, the heirs' interest in the allotment

became fractionated. It is not uncommon for a person to have a very small percentage interest in a particular allotment, in common with several relatives. This effectively precludes development, productive use or sale of the property in question, because everyone with an interest would have to agree to the use.

The land buy-back program would give fair market value to each individual who has an interest in an allotment, plus \$75. The \$75 is an added incentive for people to participate in the program.

The other reason to participate is that it is in the best interest of the tribe. A goal of the buy-back program is for the Confederated Tribes to reacquire the controlling interest in allotted properties. This would allow for a tribal determination as to its best use.

Each person with an interest in an allotment has the option participate in the program and sell to the tribe, to sell to another allottee, or to take no action.

Community outreach events on the buy-back program are coming up soon, Mr. Scott said.

Music at arts festival

Musicians from Confederated Tribes performed at the Fifth Annual Jim Pepper Native Arts Festival.

The festival, at the Parkrose High School campus in Portland, is a Native arts benefit event.

On hand from Warm Springs were Brutus 'Big B' Baez (MC), Foster Kalama, Jericho and Colton Trimble (flutes); The Flying Eagle Band with Kenman Miller; Blue Flamez with Scott Kalama, Levi Kalmaa and Andy Fuentes; Quiltman, Milton and T. Sahme.

James Greeley, 2017 nominee for two Native American Music Awards, performed with Blue Flamez, a 2016 NAMA winner last year.

The festival is in memory of Native jazz saxophonist Jim Pepper, a pioneer in Native jazz fusion. This year festival founder Sean Cruz, and environmental activist, author and executive director of Honor the Earth Winona LaDuke were on hand for the Jim Pepper Native Arts Festival.

Happy memories at Simnasho home

My name is "Ul-Loop-Sha-Lee." A fire in August took our historic home at Simnasho where I was born and lived with my father Clayton Queahpama, mother Helen Napyer, sisters Kat Q. Sybil Smartowit, Al' Queahpama and bro George "Boots" Queahpama.

Our home was old but built strong. Nothing could take it down but fire. I cried when I heard it was gone forever. But the memories will always be there for me. We lived there with no electricity or inside water, which was natural for us.

Mom kept us clean in a big tub and the Sweathouse where the creek flowed beside. And dad built a well where we used a bucket to dip our water for use in the house.

Our light was old lamps lit with matches. We had plenty to eat. My mom dug a garden for vegetables, deer meat, roots, and chickens for eggs. We didn't even know what she-up-poo food was until we went to school.

We lived down the hill where it was nice and quiet, so beside having

dogs for pets I would go catch our pet magpies, rabbits, chipmunk, goose. We had an orphaned colt, calf, and even a fawn.

Sundays were our best mornings. We ate our traditional food, and dad and mom would start drumming and singing Wash-ut songs, then we would dance our Seven Songs. That wasn't the only dancing the old house went through.

"Half shot" dad would get together with his drumming friends, Doug Jake, Sideways Ole Man Moody, and Lawrence and Artiss are a few I remember. Then the forty nine songs started about the old Model-T. All of us kids and a couple of adults would war dance and whoop around.

Such good memories, and there are pages I could write,

but I'll keep those in my mind and share stories with my sisters and brother. That's enough about me. I am sorry for my brother Milton, his home is gone as are all his mother's treasures he had put away. Also his belongings.

My sister Al and I stopped in to say Hi before the fire. I'm glad we did because it was the last time we got to see the house. Milton took us out back where he had a nice Sweat lodge.

It was nice to walk around because it was so green and cool there. I am so, so sorry, bro, for your loss. Take care, I am thinking of you.

Washanaksha is an Ichishkin word, meaning something is important: You take it in—heart, spirit, and mind—and are committed to carrying it forward no matter what.

Our culture, tribal and family history, dance, art, ceremonies, music, and traditional practices are the foundation of our identity—for each tribe and each tribal member.

The Confederated Tribes of Warm Springs Cultural Trust Committee chose the name Washanaksha because it communicates the highest purpose of this effort.

The Oregon Cultural Trust is a public funded program, and the funding is to benefit all tribal members,

other Indians, and residents of the Warm Springs Reservation.

The Washanaksha board supports projects and activities that address one of the following four priorities outlined within the Warm Springs Washanaksha Cultural Plan:

1. Promote tribal member and residents' understanding of and involvement in cultural activities, traditions, arts, language, dance, history, music, etc.
2. Pass on tribal knowledge and practices to our youth, and help them feel connected to their culture.
3. Preserve, practice and teach our tribal languages: Ichishkin, Numu and Kikshat.
4. Support the work of our artists and traditional teachers, including their ability to earn a living from their work.

Grant awards

The maximum grant award is \$1,200. The Washanaksha board wants to make awards to as many applicants as possible.

Eligibility: Applications

will be accepted from:

Confederated Tribes of Warm Springs tribal members. Confederate Tribes' programs and committees. Residents of the reservation. Warm Springs community organizations.

Grants to tribal members who reside on the reservation will be considered first. Any remaining funding will be awarded to applicants from the other three eligible groups.

Prior grant recipients must have submitted all reports required by the Washanaksha Cultural Coalition before applying for a new grant.

Projects must be completed in seven months. Project completion must occur by Thursday, July 26, 2018.

The grant is to be used solely for your project that you will describe in your proposal. Please comply with reasonable request from the Washanaksha Cultural Coalition for information about program activities.

The following are requirements for this grant:

Publicity: Cooperate with any efforts of the Washanaksha Cultural Coalition to publicize the grant award.

• The Grant Recipient Award Reception will be at the Museum at Warm Springs, in the Education Room, on Tuesday, December 5 at 5:30 pm.

Reports: A final report of the completed program will need to answer all the questions and requests regarding the project or activity.

Final reports must be turned in on deadline in order for the Oregon Cultural Trust Fund to continue funding future Washanaksha Grant projects and activities.

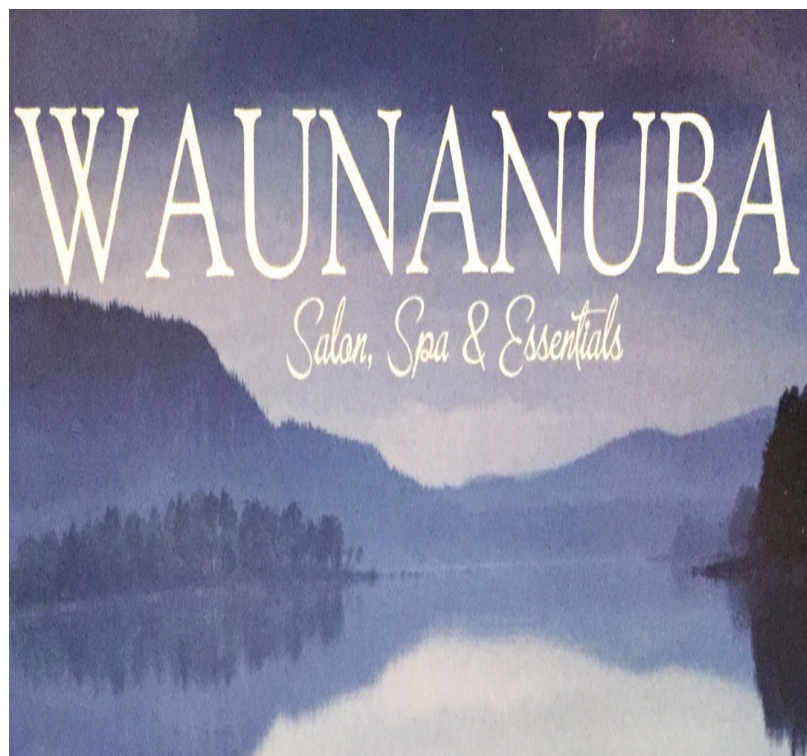

These too will be areas of focus at the new Kah-Nee-Ta.

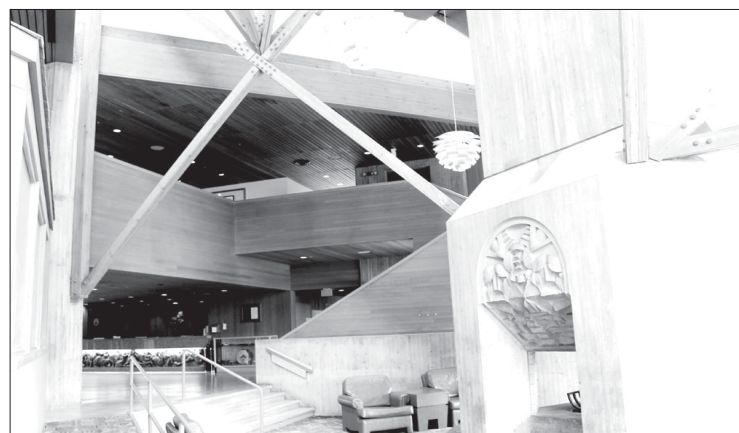
During the meeting last week with Council and the board, Mr. Hansen talked about some of his ideas: Guided kayak tours, whitewater rafting, mountain bike opportunities, a major upgrade at the stables, to name just a few.

For their part, the tribes will see a new revenue stream through the room tax at the resort. The tax would be 10 percent during the first two years, as the improvements are under way, and then 15 percent thereafter.

So instead of spending money to keep the resort open, the tribes in 2018 will realize a new revenue stream, Jim Manion said. "It's paramount that this deal is done for the continued operation of Kah-Nee-Ta," he said.

At meeting with the investors, Chief Joe Moses said the development is something the tribes have needed for many years.

Some things will not change at Kah-Nee-Ta under the new

management. The focus on Native culture, the tribal member hiring preference and certain discounts for members remain in place, for instance.

But the changes will be significant—"Changes we have needed for some time now," Mr. Manion said.

The deadline to submit is 5 p.m. this Friday, October 13. Some of the guidelines:

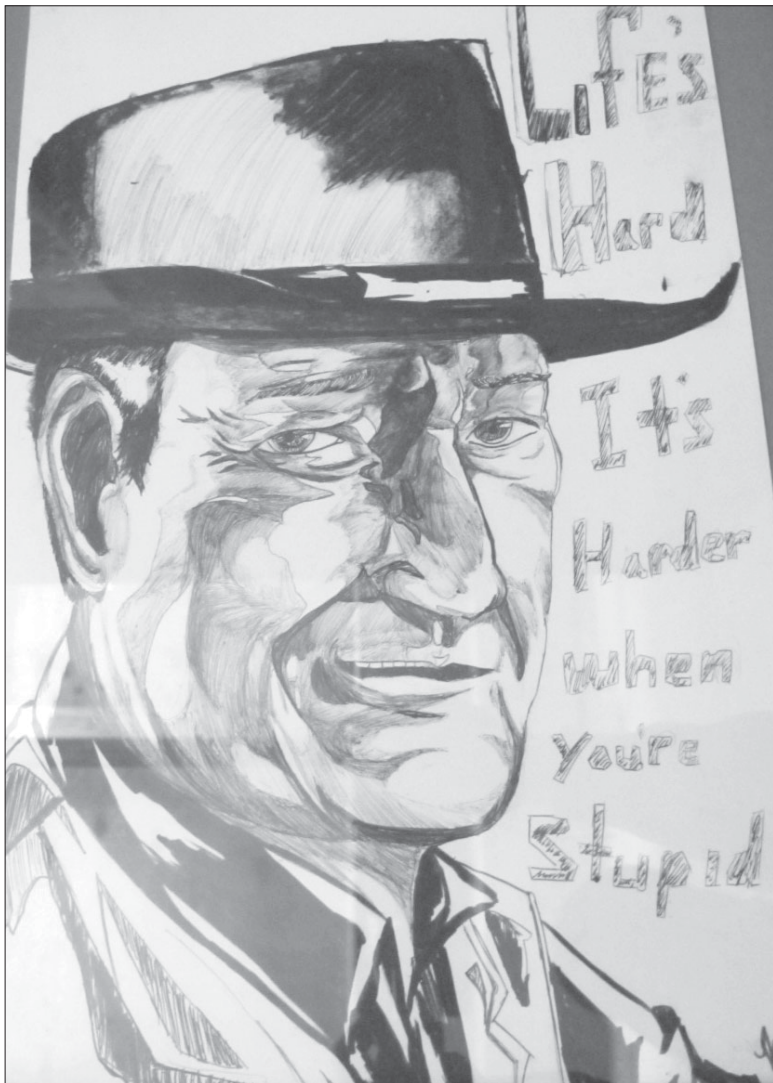
The artist must be 18 years or older, and an enrolled member of the Confederated Tribes.

Good news is that the flu vaccine appears to be a good match for this year's strain, Ms. Russell said. Community Health has flu shots available at the clinic. They will also be making visits around the community in coming weeks, providing vaccinations.

Nurses will start visiting local schools giving flu shots on Tues-

day, **October 17**. On that morning at 9 they will be at the Warm Springs Early Childhood Education Center.

On Wednesday, **October 18**, at 10 a.m. the nurses will visit the Warm Springs Academy.

On Thursday, **October 19** at 9 they will be at the Jefferson County Middle School and Madras High School. Students must have signed parent consent to receive a shot. Flu shots are also available at Pharmacy at the clinic.

Some other things to keep in mind:

Pregnant women may receive any licensed, recommended, and

age-appropriate flu vaccine.

Getting an annual flu vaccine is the first and best way to protect yourself and your family from the flu. Flu vaccination can reduce flu illnesses, doctors' visits, and missed work and school due to flu, as well as prevent flu-related hospitalizations.

The more people who get vaccinated, the more people will be protected from flu, including older people, very young children, pregnant women, and people with certain long-term health conditions who are more vulnerable to serious flu complications.

Klamath-Modoc artist featured at Water of the West exhibit

A \$100,000 grant to the High Desert Museum in Bend will help with the creation of an interdisciplinary exhibition, *Water in the West*.

The project will connect artists from multiple mediums with scientists to creatively approach the topic of water in Oregon, and explore the relationship between art and science.

The exhibition will be on display from May 2019 to November 2019. The project is funded through Oregon Community Foundation. Artistic disciplines include visual arts, music and spoken word.

Weaving together multiple artistic mediums with science and natural and cultural history, *Water in the West* will provide a compelling exploration of water in Oregon.

For the exhibition, the museum will commission four works of art that will explore a variety of top-

ics related to water in the West, including biodiversity in riparian ecosystems, how water has shaped the West's natural, cultural, and geological history, and contemporary issues, such as water usage, Indigenous rights and the impacts of climate change.

The exhibition will feature:

A visual art installation by contemporary Klamath/Modoc artist Ka'ila Farrell-Smith. Farrell-Smith uses painting and sculptural art forms, such as basket weaving and drum making, to explore the space in-between the Indigenous and western worlds, and several of her recent works have explored Indigenous water rights.

A spoken word piece composed by critically acclaimed artist/performer Jason Graham (also known as Mosley Wotta).

An intermedia art installation created by Harmonic Laboratory, a collective of artists who integrate art, science and the humanities.

Zombie Run at Kah-Nee-Ta

Kah-Nee-Ta Resort and Spa will host the first-ever Zombie Run the Saturday before Halloween. Here is how it goes:

First, you choose whether to be a Survivor or a Zombie.

If you choose to be a Survivor (or Runner):

You will start five minutes before the Zombies.

Each Survivor will have two lifelines—flags attached to a belt: The goal is to outrun the Zombies and keep both your lifelines.

Once you lose your flags, you're dead (but not a Zombie).

Zombies leave the start line five minutes after the Survivors: The goal is to chase Survivors and grab as many lifelines as you can.

Makeup artists will be on-site at Kah-Nee-Ta to apply Zombie make-up. Make-up will be done on a first come-first serve basis, so come early. (Please tip the artists: They are volunteering their time

to make you look super scary.)

Some other guidelines: Survivors may not take another runner's flags, chase other runners, or pick up flags off the ground.

Direct and intentional physical contact with any runner or zombie is strictly prohibited. You are not to touch, hit, punch, tackle, roundhouse kick, slap, scratch, pinch, spit on, bite, or do anything harmful to the physical health of our Zombies or other Runners, no matter the circumstance. Those in violation of this rule will be automatically disqualified, and potentially escorted off of the grounds without refund.

Flags must be visible to Zombies (not covered by long clothing or tutus) and are to be worn on the sides of the body.

The Peaks of Central Oregon

Evaline Patt came across this story in the book Indian Legends of the Pacific Northwest, by Ella E. Clark. She would like to share the story here:

The Oregon sky line for many miles both east and west of the Cascade Range is dominated by a series of peaks. The following stories and traditions about some of them were recalled by Lucy and Walter Miller, Warm Springs Indians, who had heard them in childhood from their grandfathers, signers of the Treaty of 1855:

The group of peaks called the Three Sisters is a prominent landscape feature in Central Oregon. Each peak is more than 10,000 feet in altitude.

The mountains were once people, our grandfathers used to tell us. Mount Adams, north of the Columbia, and Mount Hood, south of it, became jealous of each other because of some girl. So they started quarreling and fighting.

At that time there was a bridge across the river, and the two rivals would cross it to fight. Sometimes they fought on one side of the Columbia, sometimes on the other. Coyote tried to stop their quarreling, but they would not stop.

So all the other mountain peaks agreed to help him. From away down in the Klamath Marsh country they marched north for a big coun-

cil meeting. They planned to cross the Columbia on the bridge and have the meeting north of the river. The Three Sisters marched with the mountain people, and so did Black Butte and her husband.

Black Butte carried on her back a big bag of roots and berries, for food along the way.

Her husband carried a deer over his shoulder, so that they would have meat on their journey. One day the sun was so hot and the bag was so heavy that Black Butte sat down to rest. Her husband was annoyed and lay down, pouting. Black Butte was very tired. She was so warm that sweat ran

down her face and sides in streams.

Those creeks came together below her and formed the Metolius River.

But Coyote did not wait for the help of the mountain people, Mount Adams and Mount Hood were going to have a wrestling match, and Coyote knew that it would turn into a fight. So he made up his mind to keep the two men apart. He wished the bridge to fall, and the bridge fell. Mount Adams could not cross over.

When the mountain people heard that Coyote had broken down the bridge, they stopped marching.


