CME)	Employer ADR Programs While the Federal Arbitration Act was enacted in 1925, the arbitration of statutory workplace claims is largely a development of only the last 25 years. As a result of a series of Supreme Court decisions, from <i>Gilmer</i> in 1991, to <i>Circuit City</i> in 2001, to this year's ruling in <i>Epic Systems</i> , arbitration has evolved from one aspect of collective bargaining agreements and select executive contracts, to a dispute resolution mechanism that is applicable to an estimated 60 million workers. This session will address the legal foundation upon which these developments are based, and will identify the ways in which alternative dispute resolution mechanisms—including but not necessarily limited to arbitration—may exist in the workplace. Two practitioners with extensive experience—in the practical development and implementation of ADR programs, and a quarter century of appellate review of challenges to enforcement of arbitration agreements—will explain the ways in which ADR programs, and agreements to arbitrate, have transformed the ways in which workplace claims can be resolved.

In 2017, at the request of Chief Justice Donald W. Lemons, the Joint Alternative Dispute Resolution (ADR) Committee of the Virginia State Bar and the Virginia Bar Association established a Special Committee to Study Appellate Mediation in Virginia. The Special Committee included the Honorable Wesley G. Russell, Jr., Judge, Court of Appeals of Virginia. In April 2018, the Special Committee made specific recommendations to the Chief Justice, including the establishment of mediation pilot projects in the Commonwealth's appellate courts. The Special Committee also recommended a new level of certification for appellate mediators during the pilot projects, which will be presented to the Judicial Council for adoption later this year.
Judge Russell will describe the pilot projects, and discuss the potential benefits of mediation to litigants in the appellate courts in Virginia.
